## NSCNA To Seek Nonprofit Status

The NSCNA has signed an agreement with the Lucas tract developers and Town North Imports that gives the NSCNA \$25,000 (see pg. 4). Currently the association is not formally incorporated, but if we become a non-profit organization, this and other donations would be tax-exempt for us and tax-deductible for the giver. Therefore, the NSCNA has decided to pursue nonprofit status.

Nonprofit status will necessitate changes in the way the association is run. On the plus side, all contributions to the NSCNA will be tax-deductible. This includes membership dues along with anything else you might contribute to the association. Businesses that contribute to the NSCNA also will get this deduction. This encourages businesses to sponsor neighborhood projects and our newsletter.

The NSCNA also will save money by becoming nonprofit. As a nonprofit, we will not have to pay sales tax on anything we purchase. Also, we will qualify for less expensive, nonprofit postal rates for our mailings.

Of course there is a down side—namely, the added bureaucracy of being tax-exempt. Once we are nonprofit, we must meet governmental recordkeeping and reporting responsibilities. We will not be able to run ourselves as informally as we have done in the past. As treasurer, I'm thankful to Town North Imports for supplying lawyers who will help us through the complicated paperwork of filing for nonprofit status and who can educate us on these requirements.

In summary, becoming a nonprofit has two distinct advantages. All incoming money and donations become tax-deductible, and the NSCNA will save money on purchases and mailing costs. This comes at the expense of some extra minor governmental bureaucracy.

## **How To Pay Less** With Pay-As-You-Throw

The Austin City Council has authorized some changes in the Pay-As-You-Throw program. The council passed a variable base rate for 30-, 60-, and 90-gallon garbage carts. The promotional Extra-Garbage stickers that were mailed to all customers last year are valid for use indefinitely even though they carry an expiration date.

The variable base rate will allow customers who use a 30-gallon cart to receive a reduction in their garbage collection bill. All customers will continue to be required to use an Extra-Garbage sticker for any garbage that exceeds the capacity of their city-issued container.

The Pay-As-You-Throw program is designed to discourage excess garbage and encourage recycling. When the new airport opens in 1999, the city will no longer be able to accept residential garbage at the city landfill. The city will pay private landfills for garbage disposal. Recycling more will help keep landfill costs lower.



## **NSCNA Signs Deal With Town North Imports**

The NSCNA has signed an agreement with Town North Imports and developer Robert Oler in which the association allows an expansion of Town North's automotive sales business in exchange for a \$25,000 contribution toward "neighborhood traffic calming efforts or any other neighborhood project."

Town North's proposed expansion onto a portion of the Lucas tract (adjacent to Hwy. 183, near McCann Dr.) had snagged on a restriction prohibiting automotive businesses. This restriction was placed on the property in 1997 in order to prevent an increase in cut-through traffic in our neighborhood. Last winter Town North and Oler asked the association to agree to remove the restriction in a proposal that offered the association \$10,000.

After more negotiations and discussions at the NSCNA meetings of November 17 and January 26, the association agreed to a

revised proposal that provides \$25,000, plus legal help in obtaining speed humps and nonprofit status for the association, as well as specific actions by Town North that promise to reduce test-drives on our streets.

Town North has agreed to designate one of its employees as the liaison with our neighborhood. His name is Dick Grimes, and he will receive and address all neighborhood complaints about test-driving on our streets.

To enable residents to identify its cars, the dealership will place magnetic signs on them. If a resident witnesses one of these cars speeding in the neighborhood, he of she should call Mr. Grimes immediately to file a complaint, noting a description of the vehicle and the date, time, and nature of the infraction. His phone number is 832-1430. If he cannot be reached at this number, try him at Town North's main number, which is 451-7411.

Walking your dog can be fun for both you and your pet. However, allowing your pet to defecate on neighborhood lawns, streets, or public places is rude and violates city code.

City Code 3-3-7 states: "It shall be unlawful for any person to fail to promptly remove and dispose of, in a sanitary manner, feces left by a dog or cat being handled by that person on property public or private, other than the premises of the owner or handler of such dog or cat." Fines for violation of the code run from \$10 to \$500 and are enforced by the Health Department.

Let's all make our neighborhood a better place to live by picking up droppings while walking pets. And please don't empty your scooper into a nearby storm drain; doing so pollutes the Shoal Creek watershed.

## Local Library's Fate Undecided

Once slated for closure, the North Village Library now has a chance of becoming a permanent, city-owned facility. That is, if it is included on a bond election ballot and if it is approved by voters in the election this September.

Located in the shopping center on the southeast corner of Burnet Road and Anderson Lane, the North Village Library has been a rental facility for more than 25 years. It ranks 8th out of 19 branch libraries in terms of usage—remarkable given its small size and limited resources.

The library commission has recommended that the city planning commission include North Village on the bond ballot. The planning commission will hold a public hearing and then forward its recommendations to the Citizens Bond Committee and the City Council. North Village needs volunteers to help make its dreams a reality. ## Don't Ignore Graffiti-Erase It

Graffiti is gang advertisement—a newsletter for the streets. Graffiti is used to make a public announcement about the presence of gangs, their members, and their agenda for future criminal activity.

Do not ignore graffiti or fail to understand its significance. It lets you know that a gang is trying to take control of your neigh-

borhood. Left unabated, graffiti diminishes our quality of life. It perpetuates the feeling of fear and crime. And it decreases property values and discourages business in your area. If graffiti is not removed, gang members will interpret this as a sign

of low neighborhood pride, and they will assume that they can take control of your neighborhood.

Studies show that graffiti has less of a chance of reappearing if it is removed quickly. The City of Austin's Graffiti Abatement Program can assist property owners in removing graffiti. In some cases, the program may be able to supply paint or other graffiti removal materials to assist property owners.

A City of Austin ordinance passed in March 1995 establishes offenses for parents of minors convicted of defacing property with graffiti. The ordinance also establishes offenses for property owners who continue to allow graffiti to remain on their property. The main focus of the ordinance, however, is to get the community involved in helping to

eradicate graffiti. Since the ordinance was passed, for example, the Graffiti Abatement Program has averaged at least one volunteer clean-up effort a week by neighborhood groups, civic organizations, businesses, and others willing to pitch in to

clean up graffiti.

City crews also have cleaned up more than 7,000 sites, and the program has answered more than 3,000 calls to the city's Graffiti Hotline. To find out more about how you can get involved in the citywide effort to eradicate graffiti, call the Graffiti Hotline at 473-4125.



## Developers Pledge \$25K; New Officers Elected Minutes of the January 26, 1998, NSCNA Meeting

Presiding: Dallas Maham, Vice President

Treasurer's Report: Harold Anderson, Treasurer. Membership now includes 76 households. Current balance in the association's account is \$1,595.56.

Secretary's Report: Lynda Oakes, Secretary. Minutes of the meetings held September 15 and November 17, 1997, were not read because they appeared in the Winter 1997 NSC Newsletter.

Guest Speaker: Chip Harris, from the Crestview Neighborhood Association, spoke for the Friends of the North Village Library. This group is trying to place the North Village Library, on Anderson Lane, on the proposed September bond election for change from a temporary to a permanent facility. As a rental unit, the North Village Library is currently subject to closure. For further information, contact Friends of the North Village Library at 458-2488.

Annual Elections: Tomas Rodrigues presented the list of candidates that had been prepared by the nominating committee. A motion was made from the floor that the members accept the proposed slate of officers and steering committee members. The motion was seconded and unanimously approved. The 1998 officers are as follows: Dallas Maham, President; Chuck Crane, Vice President; Phyllis Milstead, Secretary; and Steven Weintraub, Treasurer. The 1998 steering committee members are Margo Courreges, Donna Eagar, Margaret Flaniken, Dora Hall, Felicia Morrison, Claire Palitza, and Montie J. Simpson. Standing committees and chairpersons are as follows: Zoning, Dallas Maham; By-Laws, John Migl;

and Traffic, Chuck and Pam Crane.

Old Business: Dallas presented a written proposal for the NSCNA from North Shoal Creek Commercial, Ltd., NSC Management, and Town North Autoplex. The proposal described a proposed change to some of the restrictions on lots 49 and 50 of the Lucastract, adjacent to Hwy. 183. It also included a pledge by the developers to give \$25,000 to the NSCNA and to reduce test-drive traffic through the neighborhood. The terms of the agreement would allow for the case to be filed with the city zoning commission as a consent/consent case.

A lengthy discussion followed. A motion was made and seconded that the agreement be rewritten to contain some revisions and the names of the new officers, and then presented to those officers for final review and signatures. The motion was unanimously carried.

New Business: John Migl, representing the By-Laws committee, moved that the members authorize the officers to take the necessary actions to incorporate the NSCNA as a nonprofit organization, and that a new incorporation committee, headed by Tomas Rodriques, be established to support the officers in this effort. The motion was unanimously carried.
