"RESOLVED, that any of the above-named parties shall be authorized individually to sign for and receive the statements and canceled vouchers of this Association, or to appoint in writing agents to sign for and receive the statements and canceled vouchers of this Association, and any of the above-named parties are hereby further authorized to stop payment against checks of this Association and to bind the Association hereto. Endorsements of the Association for deposit may be written or stamped without designation of the party making the endorsement

"RESOLVED, that the Credit Union is hereby authorized to honor any and all withdrawals of the Association's funds payable to the officer or agent signing, or countersigning the same, or payable to the Credit Union, whether such withdrawals are presented for cash or for credit to the personal Account of such officer or agent or the person presenting the same, and the Credit Union need make no inquiry concerning any such item.

"RESOLVED, that the Authorized Representative shall certify to the Credit Union the names of the presently duly elected and qualifying officers of this Association as well as the persons authorized hereunder, and shall from time to time hereafter, as changes in the personnel of said officers or the persons authorized hereunder are made, immediately certify in writing such changes to the Credit Union, and Credit Union shall be fully protected in relying on such written certification of the Authorized Representative and shall be indemnified and held harmless from any claims, demands, expenses, losses, or damages resulting from or growing out of honoring the signature of any persons so certified or refusing to honor any signature not so certified.

"RESOLVED, that to the extent that this Certification and Authorization differs from, alters, or contradicts any prior Certification and Authorization governing the opening or maintenance of Accounts of the Association at the Credit Union, and any authority conferred thereby, this Certification and Authorization shall be deemed to control in all respects.

"RESOLVED, that any individual previously authorized to act on the Association's behalf with regard to the Accounts of the Association, who is not so authorized under this Certification and Authorization, is hereby expressly removed as an authorized signer on the Accounts and any such authority previously conferred is hereby revoked, except that if an election is made to add or delete authorized signers by way of a modification rather than by closing an Account, the Credit Union may continue to honor checks or orders signed or made by any deleted signer, and the Association is

fully responsible for denying any deleted signer access to the Accounts.

"**RESOLVED**, that the authority conferred herein shall remain in force with respect to the Accounts of the Association until a new Certification and Authorization superseding the present one shall be received by the Credit Union.
