**1. Call to Order; Adoption of Agenda**

The North Shoal Creek Neighborhood Association General Membership meeting was held on March 5, 2013. The meeting was called to order at 6:33 p.m. by President Webb.

**2. Adoption of Agenda**

A motion was made and seconded to adopt the Agenda and the motion carried unanimously.

**3. Discussion of NSCNA general membership meeting locations**

President Webb discussed the status of the insurance held by NSCNA and meeting at Pillow Elementary. NSCNA now has liability insurance for this year as required by AISD. There would be no charge to meet at Pillow unless the meeting went past 8:00 p.m. and we had to pay the janitor overtime.

The Board recommends that we meet at Pillow Elementary for the general membership meetings this year. There was discussion of meeting locations. NSCNA has tried three different meeting locations as voted on by the general membership. President Webb and Lois McEvoy will get more information on the availability of chairs for the meetings at Pillow. The Board had also discussed the possibility of buying chairs for Pillow.

Since the Board of Directors had voted to recommend that general membership meetings be held at Pillow for the rest of the year, the general membership voted on it and no second was needed. Motion passed unanimously. The next general membership meeting will be held on May 7, 2013.

Past Treasurer Jeri Wines gave the 2012 Financial Report. There was discussion of the report by members. A motion was made and seconded to approve the 2012 Financial Report and it passed unanimously.

- e. Development Committee – Kevin Weir discussed the property at 8200 Burnet Road with Ross and the old Chuckie Cheese and that it has been sold to the owner of the Infinity dealership. After Ross’s two-year contract is up, they may want to build a mixed-use project on that property.
