**I. CALL TO ORDER**

President Lois McEvoy presided. Secretary Barbara Gaston recorded the proceedings.

**II. APPROVAL OF MINUTES OF LAST GENERAL MEETING**

Sharon Justice moved that the minutes be approved as read. Jerry Wines seconded. The motion carried.

**III. PILLOW PLAYGROUND**

Neighbor Becky Campbell was the leader on this project. She reported the following. She, other young mothers in the neighborhood, principal Brian Hill, school staff and representatives of Austin Parks and Recreation worked together to design the playground. They focused on the needs of students aged 2-12 years. The designated area is under the trees and will consist of four small areas which will be completely redone. An effort will be made to make it look like a more natural setting.

The pea gravel will be replaced and the area will be enhanced with natural colors, mostly tan and green. Features to be included are a rockclimbing wall, playscape small rope climbing area, a slide, swings and a tire swing. The equipment has already been bought by the city, and installation is expected to be finished by spring.

Negotiations are underway to finalize permission for members of the community to use the playground during school hours if school children are not using it during recess. Formerly, the playground was closed during school hours of 7:30 am-3:30 pm.

At this time a member of Pillow School staff announced that the school is in need of a person who is fluent in Arabic. If interested, please call the school.

Vannessa Smith, who lives on Ashdale, reported that she has seen numerous unusual events involving a men's domicile on Burnet Road. The Austin American-Statesman reported that it has been cited by state agencies and the Austin police department for unsafe practices. She added that the Ashdale area has had numerous incidents of car break-ins and vandalism.

## **VII. OLD BUSINESS**

### **A. Discussion of the Sackman notice (handout) followed:**

- B. Speed control on Stillwood is in a state of flux. The city will address this issue sometime this year. Other areas in our neighborhood have traffic control issues also. Questions can be addresses to the traffic committee chairman, Tomas Rodriquez. He was absent at this meeting.
- C. A complaint was made that 18-wheel trucks park and unload new cars on Rockwood despite there being a sign in full view that says, "No Trucks." Attendees were reminded that NSCNA is not a home owners association. It is a neighborhood association, and anyone living within our borders may join. A neighborhood association cannot enforce rules, as can a home owners' association.

## **VIII. NEW BUSINESS**

### **A. PILLOW SCHOOL PRINCIPAL BRIAN HILL**

Mr. Hill was introduced to the group. He provided the following information. The library is being expanded to the sidewalk in front. Current library facilities are housed in a temporary building positioned to the back of the main school building. The construction is expected to be complete in March. The new addition will have new shelves, additional technology paid for by a recent school bond, and conference and A/V rooms.

Pillow's functional capacity is 502, without portable buildings. This year's attendance is about 550. Last year's was about 580.

Anyone wishing to volunteer at the school can call the school and speak to one of the two part time counselors.

### **B. AGING PLUMBING IN AREA HOMES**

As our houses age (many built in the 1960s), pipes become corroded and need to be replaced. This is an expensive and massive undertaking. Several of our neighbors have been faced with it. Routine house inspections at time of sale do not cover it. Insurance payment is not guaranteed. This is an ongoing fairly new problem. It is something for the buyer and the seller to keep in mind.
