Hosting the website costs \$119.04. It was renewed on 11/21/17. The Board agreed that NSCNA will reimburse Kenneth for paying the 119.94 with his personal credit card.

# VIII. DISCUSSION OF NSCNA CONTRIBUTING MONEY FOR CodeNEXT LAWSUIT

Group discussion involved the legality of CodeNEXT as it pertains to other city planning documents. Code NEXT is not consistent with the Land Development Code. According to Texas law, CodeNEXT is illegal because it does not follow the zoning regulations of the Comprehensive Plan as set forth in Imagine Austin and the various Neighborhood Plans. Sharon Justice (Lois McEvoy) moved that the Board adopt the position that NSCNA cannot support Draft 2 of CodeNEXT as it is currently written. Motion carried.

A petition to put CodeNEXT up for voter approval is being circulated. The petition would not prevent a lawsuit. Timeline regarding the petition is unknown.

The Board did not reach a decision regarding contributing money for a lawsuit.

### IX. JANUARY MEETING

The meeting will feature a round table discussion about CodeNEXT and the Neighborhood Plan.
