Treasurers report – Lois McEvoy

Money is generated via membership dues, ads, interest, garage sales, etc. Last year, we had 73 members. For our budget forecast, we projected 86 memberships, which is about 10% of the households in the neighborhood.

Lois will produce a financial statement quarterly. NSCNA files 99N (non-profit with the state of Texas). Membership dues are *not* tax deductible.

Committee Reports

Beautification - Lynda Oakes

Lynda is in the process of building a contact list. There are some carry-over suggestions from last year. She hopes to have a meeting soon.

Development - Kevin Wier

First Texas Honda and the Infinity dealership are owned by the same person. Potential car buyers should not be test driving through the neighborhood. The First Texas Honda dealership ran into construction delays, so it might open as late as 2011. Waterloo Ice House will be renovating and expanding. Sustainable Neighborhoods group works with city planners to work on neighborhood-friendly development.

Media – Cheri Hartman

Newsletters and flyers were sent before the general membership meeting. Cheri needs volunteers for writers, pictures, and advertising (either you want to advertise or you know someone who wants to advertise). There is a wider variety of advertising prices and size selections this year including a business sized ad. There is a big push to keep the NSCNA.org website up to date. Also, the Yahoo group is now overseen by an administration team that enforces the guidelines.

Membership – Barbara Gaston, Lois McEvoy, Vicki McFadden, Sherran Williams

Vicki spoke on behalf of the membership committee. The committee's goal is to increase membership. The membership committee conducted a telephone outreach program before the general meeting and was able to recruit several NSCNA members. The committee also provided membership flyers with the NSCNA newsletter with the help of Cheri and Alyssa. The flyers were based on a flyer produced by NSCNA several years ago. The cost of the flyer was paid for by advertising. Membership is currently at 71 members.

Safety - Don Jones

Don is looking for volunteers to help with the safety committee and for input from members. He is trying to improve communication and collaboration between APD and NSCNA. He has subscribed to the APD update e-mails regarding local area crime. He will try to keep members updated with tips on how to keep the neighborhood and personal homes safe.

Social – Alyssa Hedge

Alyssa is looking for volunteers and committee members. There are several ideas such as Spring Fling, movie night, special interest groups (knitting, gardening, book clubs, etc), and cross social events with other neighborhood associations.

Traffic - Dallas Maham

The traffic committee works with the City of Austin regarding traffic (walking, bicycling, and driving). Dallas is looking for volunteers and for people who might have connections with city officials.
