Treasurer's Report

We are under budget for 2023, but we have upcoming expenses of \$300 budgeted for Luminaria and the fee for the Dreamhost website service, for which \$250 is budgeted. Josh shared his understanding that dipping into the money market fund has occurred in the past. John will transfer money to ensure we do not overdraw the checking account.
